May I now have an answer, please?

Mr. Lamontagne: Mr. Speaker, this is exactly the same question as that asked by the hon. member for Port Arthur. I have not yet received an answer from the C.B.C. When I do receive it I will be very glad to give that answer to the House of Commons.

Mr. Fisher: A supplementary question. I should like to ask the minister whether the question put by the hon. member and other questions which have been put could not be answered to a considerable extent without resort to the C.B.C., since they involve his associates in the cabinet.
