FACE VALUE OF COMMEMORATIVE POSTAGE

Question No. 1,717-Mr. Nesbitt:

- 1. What is the face value of the commemorative postage stamp being issued on March 14, 1969?
- 2. How many stamps of this issue are being printed?
- 3. What is the price of each stamp to the general public?
- 4. Are orders being taken by the Post Office Department for these stamps and, if so, what price is being charged?
- 5. Is there any limit to the number of stamps this issue that can be purchased by one customer?

Hon. Eric W. Kierans (Postmaster General): In so far as the Post Office Department is concerned: 1. The Aurele de Foy Suzor-Côté commemorative stamp has a face value of 50 cents.

- 2. Six million stamps of this issue were ordered, but with the usual overrun total printing should approximate 6,300,000 stamps.
 - 3. 50 cents.
- 4. The Philatelic Service located at Headquarters accepts mail orders from stamp collectors and all sales both from post offices or the Philatelic Service are at the face value of the stamp.
- 5. There is no limit to the number of stamps of this issue that may be purchased in post offices by one customer. However, the Philatelic Service makes every effort to ensure that all collectors have an equitable opportunity to obtain each new issue stamp through its facilities and the Philatelic Service would not knowingly allow one collector to obtain excessive quantities of any new issue stamp before the stamp has been available to all collectors for a reasonable period of time.
