APPLICATION OF LOW-RENT HOUSING PROGRAM TO SMALL TOWNS

Mr. Gérard Laprise (Abitibi): Mr. Speaker, I would like to put a question to the Minister without Portfolio in charge of housing.

Could he tell the House whether the \$200 million program for the construction of low rental housing is giving satisfactory results and does he intend to renew that program for 1971 and to apply it in small towns?
