should be made regarding the situation which resulted in the bringing in of the War Measures Act.

#### Some hon. Members: Hear, hear!

**Mr. Speaker:** Order, please. I cannot quarrel with the statement made by the right hon. gentleman but if a statement of this kind were to be made it would not be as the result of an inquiry of the minister in question, but a request of the Prime Minister or the Minister of Justice. My impression is that this is what was requested previously during the question period. The hon. member for Egmont.

**Mr. David MacDonald (Egmont):** Mr. Speaker, I noticed that the minister is rising. In view of the minister's direct intervention in the municipal election in Montreal, I wonder whether he is now prepared to make a statement to the House, particularly in view of the serious charges that were in fact made by the minister outside the House?

### [Translation]

Mr. Marchand (Langelier): Mr. Speaker, on a question of privilege.

We have no intention of interfering, either directly or indirectly, in the municipal election in Montreal. There is nothing to withdraw from the statement I made yesterday. However, there has obviously been some confusion due to the fact that, because of my imperfect command of the English language, I used the English word "front" instead of the French expression "caution morale". I shall clarify this outside the House.

**Mr. MacDonald (Egmont):** Mr. Speaker, in view of the danger of innuendo and smear, will the Prime Minister not agree that the time has arrived for full and concise information as to the exact nature of the apprehended insurrection as asked for earlier in the House?

Mr. Lewis: Mr. Speaker, may I address a very simple question to the Minister of Regional Economic Expansion. In view of the statement he is reported to have made, would he not agree to make a statement on motions—I am sure hon. members would gladly revert to motions now to give him the opportunity—explaining the statement he made about FRAP and giving the House the evidence on which he made that statement which has smeared a good many innocent people?

Mr. Stanfield: Dictatorship.

An hon. Member: Including his own friends.

Mr. G. W. Baldwin (Peace River): Would the Minister of Justice, as the chief law officer of the Crown, discuss this matter with his colleague to ascertain if his colleague has facts in connection with which there should be further investigation, and then report his findings to the House?

**Mr. Lorne Nystrom (Yorkton-Melville):** Mr. Speaker, may I direct a supplementary question to the Minister of Regional Economic Expansion. In order to clarify certain matters, can the minister say in the House whether or not FRAP is a front for the FLQ?

Mr. Speaker: Order, please. The hon. member for Nanaimo-Cowichan-The Islands.
