2. Applications are made by the applicant air carrier and are processed in accordance with the general rules of the Canadian Transport Commission, including public notice and an opportunity for air carriers or other interested parties to intervene in support or in opposition and for the applicant to reply to such interventions. The Commission may, at its option, hold a hearing in the light of the application and materials before it. The granting of a licence is governed by subsection 16(3) of the Aeronautics Act: The Commission shall not issue any such licence unless it is satisfied that the proposed commercial air service is and will be required by the present and future public convenience and necessity.
