# SPLITTING OF CREDITS FOLLOWING MARRIAGE BREAKDOWN-LEGISLATIVE ACTION QUERY

**Mr. Vince Dantzer (Okanagan North):** Madam Speaker, my question is directed to the President of the Treasury Board who will know that in the Green Paper on pension reform, strongly endorsed by the Minister of Finance and the Minister of National Health and Welfare, there was a call for the splitting of pension credits on marriage breakdown. Does the Minister intend to change the Superannuation Act and the Diplomatic Service Act regarding that particular item?

Hon. Herb Gray (President of the Treasury Board): Madam Speaker, this kind of question and a number of others involving the Superannuation Act will be considered by the Government in the context of the debate on the Green Paper. As yet the Government has not taken any decision with respect to proposals in the Green Paper concerning the private pension system, and we feel our decisions with respect to any changes in the Public Service system should be in the context of our consideration of the larger issues.

**Mr. Dantzer:** Madam Speaker, the National Action Committee on the Status of Women and the National Council of Women are today appearing before the Pension Committee. I am sure those groups will be very sorry to hear that the Government is dragging its feet on this issue when it should be the leader.

## PROTECTION SOUGHT FOR EX-SPOUSES OF ARMED FORCES PERSONNEL

**Mr. Vince Dantzer (Okanagan North):** Madam Speaker, my supplementary question is directed to the Minister of National Defence. It is my understanding that the Canadian Forces Superannuation Act does not include any provision for splitting of pension credits on marriage breakdown. The Minister will admit this is particularly important because members of the Armed Forces travel all over the world and it is very difficult for their spouses, who usually travel with them, to get employment during their careers. I would like to know what the Minister is doing to protect those spouses in the event of marriage breakdown.
