The work of the W.C.T.U. has been greatly augmented since the war, and the effect of the lark of housing ac-commodation for young business girls has grown so markedly that Willard Hall is filled to its present capacity and applicants are refused daily for lack of space. The new building will be devoted entirely to dormitories. The dining-room, kitchen and parlors of the present building will be rearranged to take care of the extra number of girls permitted by the extension. Willard Hall is intended to provide a residence at moderate rates for

a residence at moderate rates young girls who are getting their first foothold in the city No girl may stay longer than three years, and no girl is admitted as a resident who is over 25 years of age. It is hoped that by enlarging its dormitory accommo-dation by 200 rooms Willard Hall will be able to broaden its work for business girls in still greater proportion.




