continuation of passes and the appropriate financial responsibility for them is a matter to be discussed between VIA Rail, on the one hand, and the two railways on the other. It has seemed to be logical that the passenger service, as such, ought not to bear the cost of passes for those engaged in non-passenger service on the railways. That is an internal matter and a matter of arrangement between the railways and VIA Rail. At this point, I think there should be no reason for anyone to worry about the passes changing in their nature.

**Mr. Blackburn:** When VIA Rail becomes operational, will it also provide a pass service for employees on an ongoing basis?

**Mr. Lang:** Mr. Speaker, perhaps I should not try to pre-judge that, since it will be the kind of question dealt with by management. I think the normal thing would be to begin with many of the same arrangements that are now well known. To the great satisfaction of the unions involved in the changeover from CN and CP to VIA Rail, we have introduced and developed certain regulations to make sure that the changeover is as smooth as possible. Obviously, this will be a matter of significant concern and discussion. Perhaps I should not go further than that in my comments today.
