PRINCE EDWARD ISLAND :

1. House resolves to go into committee on the admission of Prince Edward Island into the Dominion, and the Message of His Excellency on the subject, 384. Considered ; Report a series of Resolutions specifying the terms of admission, 401. Address to Her Majesty ordered thereon, 403. See *Addresses*, 2.

2. House goes into committee respecting the admission of Prince Edward Island as a Province of the Dominion ; Report Resolutions for applying to that Province certain Laws of Canada, after such admission, &c., 411. Bill presented, 412. See *infra*, 3.

3. Bill respecting the admission of the Colony of Prince Edward Island as a Province of the Dominion ; Ordered, 410. Presented ; Read twice, 411. Passed, 425. By the Senate, 429. R.A., 435. (36 Vic., c. 40.)

PRINTING, PARLIAMENTARY :

1. Joint Committee on Printing :—Members on the part of the Commons, 5, 18, 40. Communicated to the Senate, 41. Members on the part of the Senate, 50. Documents referred for printing, 98, 136, 163, 230, 309, 316, 343, 366, 388, 395. FIRST REPORT, on the quorum ; Quorum to be eleven, 54. SECOND REPORT (on the Printing and Binding Accounts of the past year), 94 : Concurred in ; and the Clerk's report to the Joint Committee to be printed in the Votes, 163. FIFTH REPORT, recommending an advance of prices to the contractor, 230. (App. No. 1.) Motion to adopt the Report ; Amendment moved, that the principle of advancing contract prices, if admitted by Parliament, will affect the whole system of letting public works by tender, and is especially dangerous in view of the Pacific Railway and other extensive contracts about to be entered into, &c. ; therefore the Report should not be concurred in, but that Mr. Taylor be relieved of his contract, if he desire it ; Amendment, that the contract rates be advanced to the same rates as those of the printing trade generally, as reported by the Queen's Printer, viz., 27 per cent., carried ; Main motion as amended, further amended by adding " and that the said increase of prices shall commence with the work of the present Session ;" Agreed to, as amended, 391. TENTH REPORT, recommending that tenders for new contracts for Printing and Binding be advertised for during the Recess ; Concurred in, 425. OTHER REPORTS, recommending that certain documents be printed, and that others be not printed, 98, 181, 323, 390, 415, 425. Reports concurred in, 163, 415, 425.
