Her Majesty, Her Heirs and Successors may, at any time after fifteen years from the complete construction of the said Canal assume the possession and property thereof, and of all the property which the said Company is hereby empowered to hold, and shall then have, and of all the rights, privileges and advantages vested by this Act in the said Company 10 (all which shall, after such assumption be vested in Her Majesty, Her Heirs and Successors) on giving to the said Company two years notice of their intention to assume the same, and on paying to the said Company within three months of the expiration of such notice the whole current amount of their capital stock according to its value, at that time, and 15 twenty-five per cent. additional thereon.

Map and book be deposited and Canal completed within certain time or this and void.

LI.
