Glowing Tributes Are Paid to Late Rt. Hon. F. A. Anglin

High tribute to the late Rt. Hon. Francis A. Anglin, former Chief Justice of Canada for nine years, whose death occurred at his residence yesterday afternoon, was paid by prominent Canadians in Ottawa and in other parts of the Dominion last night, for his reputation as a jurist had spread far and wide during his lifetime.

All spoke of the many fine qualities possessed by the late Chief Justice who for years adorned the bench of the Supreme Court of Canada.

When the Supreme Court opens at 10 o'clock this morning, Rt. Hon. Lyman P. Duff, acting chief justice, will speak on behalf of that court, regretting the passing of their former colleague. An opportunity will be afforded also to members of the bar present to pay their respects to the memory of the late Chief Justice.

Among those paying tribute to the former Chief Justice were Rt. Hon. W. L. Mackenzie King, Liberal leader, Rev. Father D. F. Finnegan of St. Joseph's church; Hon. Hugh Guthrie, K.C., minister of justice, and Chief Justice Sir Douglas Hazen of New Brunswick.

Rev. Father D. F. Finnegan, parish priest of St. Joseph's Catholic church, which the late Chief Justice attended for many years, spoke as follows: "The former Chief Justice was a gentleman of many fine parts; clear vision, sound judgment, a true friend, and a strong Catholic."

Mr. Mackenzie King.

Rt. Hon. Mackenzie King paid the following tribute to the late former Chief Justice Anglin:

"To the friends of the Right Honorable F. A. Anglin, there will be less of surprise than of sorrow in the word that the late chief justice of Canada barely outlived the day of his retirement from the high office to which he was appointed in

1924, and which he filled with such great distinction. For some time past, it has been apparent that only the power of a most exceptional will could account for the tenacity with which he sought to continue to discharge his judicial duties. When the call to duty no longer sounded, the imperative summons was certain soon to be heard and obeyed.

"It was a kindly fate which permitted the late Chief Justice since tendering his resignation to read for himself of the esteem in which he was held by the judiciary and members of the legal profession, and of the place his name had won in Britain as well as in Canada. The appreciation of his high attainments and eminent career, which found expression at the time of his retirement, are still fresh in the minds of all. There is little that could be added to what has already been said in the press, wholly irrespective of party affiliations, of his services to his profession and to the country. The many acknowledgments of his indefatigable industry, his high integrity and his conspicuous abilities, which were made at the time, will be lasting tributes to his memory.

"The deepest sympathy will be felt for Mrs. Anglin, for the members of her family, and for the sisters and brother of the late Chief Justice, who have been so greatly bereaved."

Hon. Hugh Guthrie.

Hon. Hugh Guthrie, minister of justice, made the following comment upon the death of Chief Justice Anglin:

"The death of Chief Justice Anglin has removed from the scene a great Canadian jurist whose long and honorable career at the bar and upon the bench in Canada will long be remembered in the legal profession. The late Chief Justice in his earlier years enjoyed a very legal practice in Ontario and many briefs in important cases before the courts of Ontario, and before the Supreme Court of Canada. His elevation to the Court bench in Ontario came time when he had barely reached middle age, but so outstanding his career as a judge of the courts that his promotion

Supreme Court of Canada soon followed. His career as a judge of the Supreme Court has been characterized in a very marked degree by ability and industry, and by legal attainment of very high order.

"Many of the judgments pronounced by the late Chief Justice in important cases which came before him for decision will long stand as landmarks in Canadian jurisprudence. Upon the death of the late Chief Justice, Sir Louis Davies, the choice of a successor fell upon Mr. Justice Anglin, as he was then known, and his appointment to the high office of Chief Justice of Canada met with general approbation throughout the Dominion. Subsequently, the late Chief Justice sat upon several occasions as a member of the judicial committee of the Privy Council, where his thorough grasp of legal principles and his wide knowledge of affairs enabled him to render valuable service while sitting upon the highest judicial tribunal in the British Empire. His death will be deeply felt by the Bench and Bar in England as well as in Canada.

"The late Chief Justice Anglin always maintained a close connection and a genuine interest in the proceedings of the Canadian Bar Association. He was a regular attendant at the meetings of the association and took an active part in all its proceedings. Upon many occasions it fell to the lot of Chief Justice Anglin to act as the deputy of His Excellency the Governor-General, and in the performance of parliamentary and other gubernatorial duties and functions his conduct was always marked by great dignity and precision. Death has now removed a great lawyer, a great judge, and a great Canadian."
