

Page 2, line 40—Leave out from “signature” to “signature” inclusive, in page 2, line 43, and insert the following, as Clause E. :—

*Clause E.*—“Every such By-law shall be published and promulgated in the manner prescribed by the *Lower Canada* Municipal Act, for the publication and promulgation of Municipal By-laws.”

Page 3, line 4—After “contested” insert the following, as Clause F. :—

*Clause F.*—“When any By-law prohibiting the sale of intoxicating liquors, shall have been annulled by a competent tribunal, the Council by which the By-law was passed may within thirty days next after the rendering of the judgment to that effect, pass another By-law having the same object as the By-law so annulled, and during the said thirty days, the said Collector of Inland Revenue for the Revenue Division concerned shall not grant any of the licenses which were or were intended to be prohibited by the said By-law so annulled.”

Page 3, line 23—After “himself” insert the following as Clauses G. and H. :—

*Clause G.*—“The provisions contained in the fifth, fifteenth, twenty-second and twenty-fifth sub-sections of section twenty-eight of the said Municipal Act, are extended to Local Municipalities generally.”

*Clause H.*—“Section five of chapter twenty-nine of the twenty-fourth *Victoria*, shall be amended by substituting the words ‘Local Municipality’ for the words ‘town or village’ in the third line of the said section.”

*In the Preamble.*—Page 1, line 1—Leave out from “to” to “therefor” in line 3, and insert “amend the *Lower Canada* Consolidated Municipal Act in the manner hereinafter set forth.”

*In the Title.*—Leave out from “to” to “Lower” in the following line, and insert “amend the Municipal Act of.”

The said amendments, being read a second time, were agreed to.

*Ordered*, That the Bill be read the third time, on Thursday next.

The House, according to Order, resolved itself into a Committee on the Bill to amend the Post Office Act; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. Jones (South Leeds) reported; That the Committee had gone through the Bill, and made amendments thereunto.

*Ordered*, That the Report be now received.

The Honorable Mr. *Alley*n reported the Bill accordingly; and the amendments were read, and agreed to.

*Ordered*, That the Bill be read the third time, on Thursday next.

The Order of the Day for the House in Committee on the Bill to amend chapter 40 of the Consolidated Statutes of *Canada*, intituled, “An Act respecting Emigrants and “Quarantine,” being read;

*Ordered*, That the said Order be discharged.

The House, according to Order, resolved itself into a Committee on the Bill to incorporate the *Montreal* Literary Club; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Street* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

*Ordered*, That the Bill be read the third time, on Thursday next.
