SOCIALIST EXPELLED BY PRINTERS' UNION

candidate for Governor in a Fight With Syracuse Types.

Syracuse, Sept. 11.—Charles H. Corrigan, the Socialist candidate for Governor of New York State in the next state election, is involved in a fight with the Typographical Union No. 65, of which he has been a member up to a few weeks ago. Mr. Corrigan was charged with having written in his socialist speech a derogatory reference to the union of which he was a member, and from which he had a working card. He was suspended from the union until a fine was paid. He paid no attention to this, and was expelled and discharged from Lyman Bros., where he was employed as a printer. This was done at the instigation of the union.

Mr. Corrigan, through his attorney, procured a temporary injunction from Justice Scripture at Rome, restraining the union from interfering with his employment. The writ is returnable on Sept. 21. He also asks for a writ of mandamus to compel the return to him of his working card, and sues the officers of the union for \$3,000 damages. The suit is against Arthur A. Hay, president of the union, and Thomas M. Caffrey, Andrew J. Moynihan, Fred H. Brown, James McCormick, and John H. Hatch as executive committee, and John J. Gibson.

MISS GOLDMAN TOLD STORIES

She Denied Her Identity When Arrested.

Called Czolgosz a Fool—Denies Plotting and Says She Never Advocated Violence.

Chicago, Sept. 10.—Emma Goldman, whose speeches are alleged to have fired the brain of Leon Czolgosz, the would-be assassin of President McKinley, was arrested shortly before noon.

Miss Goldman's manner was defiant as she was led into the office of Chief of Police O'Neil, but she disclaimed all knowledge of Czolgosz and his crime, admitting only that she met him in Chicago July 12.

"Do you know that your words are what Czolgosz claims stirred him to shoot the president?" she was asked. "I do not, I never advocated violence. I scarcely knew the man."

"I was leaving for Rochester via Buffalo, when Czolgosz had a few words with me. He said he had heard me lecture in some memorial hall in Cleveland last May and that he wanted to know me."

"The how do you know that this man is the one who tried to kill the president?"

"Oh," with a shrug of the shoulders, "I guessed that from what the newspapers say."

"What did you think when you heard that an attempt to kill the president had been made?" the woman was asked.

With a wave of her hands and another shrug of the shoulders she answered disdainfully.

"I THOUGHT, OH, THE FOOL."

The prisoner's manner had been growing more and more excited, although she made an effort to control herself. In this she finally succeeded, and launched into a discourse of the teachings of the anarchists.

She declared that anarchy did not teach men to do the act which had made Czolgosz despised and hated the teachings of the anarchists.

"We work against the system, and education is our watchword," she said. "It was early last July when I came to Chicago to visit the Isaacs family."

She continued, in answer to interrogations concerning her whereabouts recently.

"I AM AN ANARCHIST."

"On the night of July 12 Isaacs was out of the house. The bell rang and I went to the door. The man who, I learn through the newspapers, was Czolgosz stood there. He said he wanted to see me. I was about to catch the Nickel Plate train, as I and Isaacs' daughter were about to go to Rochester. He went to the Rock Island, and with us, but was so busy taking leave of my friends that I scarcely noticed him. It was not a time when one would want to make new friends."

"I had the feeling that I had the few words with him of which I have just told. That is all."

"I am an anarchist, a student of socialism; but, nothing anything I ever said to Leon Czolgosz, nothing I would have him to do the act which startled everybody on Friday."

PRESIDENTIAL SUCCESSION

Lesson Learned From the Death of Garfield.

Circumstances Attending His Assassination and the Previous Murder of Abraham Lincoln.

PRESIDENTIAL SUCCESSION.

Three presidents of the United States have fallen at the hands of assassins within the last thirty years.

President Lincoln was shot at 9 o'clock on the night of April 14, 1865, and died at 7:22 on the morning of April 15, 1865.

President Garfield was shot on the morning of July 2, 1881, and after a lingering illness died on Sept. 20, 1881.

The shooting of President McKinley has occurred just the morning of Sept. 2, after his second accession to the presidency.

From the moment President Lincoln received the bullet of Wilkes Booth there was no prospect of his recovery.

His devoted wife and members of the cabinet remained with him through the night, and he died when all Washington was in a fever of excitement over the attempts on the life of Lincoln and Seward.

Garfield shot in Washington. President Garfield was shot on the Pennsylvania railroad depot in Washington as he and Secretary Blaine were about to depart for Long Branch.

As the two distinguished men were passing through the ladies' waiting room two pistol shots rang out upon the open air. Mr. Blaine saw a man running and started toward him.

He immediately saw the president arch forward and fall. A moment afterward the assassin, Charles J. Guiteau, was seen running toward the president.

In answer to his eager question his physicians informed Mr. Garfield that he was in a fair way to recover.

"Then, doctor, we will take that chance."

Gen. Arthur was in New York when the news reached that at night, but the president had passed away. Among those who joined Gen. Arthur at that solemn moment were Elihu Root, John Hay, and others.

Mr. Blaine and his associates of the Garfield cabinet had telegraphed en masse to take the oath of office.

On the morning of Sept. 21, Gen. Arthur took the oath of office, which was administered by a call official of the city of New York.

NO ACTING PRESIDENT.

The course pursued during the lingering illness of President Garfield appears to be a precedent directly applicable to the present condition of affairs.

President Garfield, without doubt, was incapacitated to perform any executive duty, although he was himself in a certain sense. There was no one to take his place.

In fact, the people did not desire during such a critical emergency.

The lessons of Garfield's death led to the enactment of a law providing a mode of succession to the presidency. This established the case of the death or disability of the president and vice-president.

The succession should devolve upon members of the cabinet in the following order:

Secretary of state, secretary of treasury, postmaster-general, attorney-general, secretary of the interior, secretary of the navy, secretary of the war.

The new law made no construction of "disability." An important provision of this law is that whenever the duties of the presidency shall devolve upon any of the persons named in the order of succession, he shall then in session, or if it would not meet within twenty days, then it shall be the duty of the new president to issue a proclamation convening Congress.

extraordinary session, giving twenty days' notice of the time of meeting.

LAW OF SUCCESSION.

In case the skill of the physicians at the president's side prove unavailing and the nation's chief executive passes away, Vice-President Theodore Roosevelt will become president.

There will be no delay in administering the oath.

Until President Garfield was assassinated, the law provided that the rule of succession, Chester A. Arthur, being vice-president when Garfield died, took the oath of president.
