REPEAL PASSES THE HOUSE.

FREE COINAGE PROVES TO BE A VERY DEAD ISSUE.

The Bland Amendment for Free Coinage at the present time, it is estimated by 109 yeas and 103 nays, is a very dead issue.

WASHINGTON, Aug. 28.—The Wilson bill to repeal the Sherman Act has been reported in the House. The Bland amendment, which provides for free coinage at the present ratio, was voted on and defeated by a vote of 225 to 123.

The vote against 13 to 1 was 123 to 1. The vote on a ratio of 19 to 1 was 237 yeas and 103 yeas. Votes to follow will result in repeal.

The 201 amendment and the amendment to re-enact the Bland-Allison act were defeated.

The Wilson bill, including the repeal, was passed, 241 to 100.

The vote in the House to-day were remarkable for the very high percentage of members who responded to the call.

Speaker Crisp did not vote, leaving but one whose absence was unexplained.

The vote upon the restoration of the Bland-Allison Act made the best showing for the silver since the act was passed.
