HOGS-REQUEST FOR INCENTIVE TO INCREASE QUALITY

If not, is any other form of incentive being considered by which we might encourage the production of quality bacon?

Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, I am sure my hon. friend is aware of our new grading procedures for determining high quality hogs. I am sure these will be beneficial in encouraging production of the kind of hog that is most acceptable to the consumer.

MANITOBA—PROVISIONS FOR HARVESTING GRAIN AND POTATOES

Mr. Ed Schreyer (Selkirk): Mr. Speaker, I should like to direct a question to the Minister of Agriculture. Can he say whether officials of his department are engaged in drawing up contingency programs to be applied in the event the grain and potato harvesting situation in Manitoba worsens?

Hon. H. A. Olson (Minister of Agriculture): Yes, Mr. Speaker. Of course the Department of Agriculture has responsibility for the Board of Grain Commissioners, which in turn the particular producers he has in mind. [Mr. Hales.]
