Inquiries of the Ministry

in British Columbia has been charged with violation of trust as a public officer and with theft of over \$50, will the minister undertake to inquire into the ramifications which may flow from the laying of those charges?

Hon. L. T. Pennell (Solicitor General): I am not familiar with the case and of course it would not be appropriate for me to make any comment at this time. I will discuss it with my colleague the Minister of Indian Affairs and Northern Development after the trial in order to ascertain if there are any related matters that require attention.

REQUEST FOR COMMITTEE CONSIDERATION OF AMENDING LEGISLATION

## ADMINISTRATION OF JUSTICE

REQUEST FOR STATEMENT ON EFFORTS TO CONTROL DRUG TRAFFIC

On the orders of the day:

Mr. R. N. Thompson (Red Deer): I direct my question to the Solicitor General. In view of the increasing number of reports regarding the serious effects on young people of the use of illicit drugs; the growing evidence of increasing traffic in drugs; also in view of the recent recommendations of the Canadian Medical Association relating to the dangers of such illicit drugs which require legal and social restrictions against their distribution—

Mr. Speaker: Order, please. Would the hon. member kindly ask his question?

Mr. Thompson: I am coming to that, sir. Would the Solicitor General inform the house whether his department is considering any specific action for more effective control of this dangerous situation, including control over the dissemination of material and television programs which encourage the use of drugs?

Hon. L. T. Pennell (Solicitor General): The R.C.M.P. is making a forceful effort to deal with the problem. The scope of the problem is revealed by the increase in the number of prosecutions for drug offences from 943 in 1966-67 to 1,915 in the first 11 months of 1967-68. As recently as last week the deputy commissioner of R.C.M.P. operations met with officials of the bureau of narcotics in Washington as part of a continuing consultation. A few weeks ago the commissioner convened a special meeting of all assistant commissioners heading the eight divisions across Canada for the purpose of discussing, among other things, matters relating to drug trafficking. Of course the R.C.M.P. is in touch with every agency on the continent-
