ly opposed the rise in interest rates and which is now defending increases in interest rates by saying that they are necessary and something over which we have no control. When the Conservatives were in opposition they attacked the Liberal government almost monthly because the cost of living was increasing regularly and rapidly. They were calling on the government of the day to do something about the increased cost of living. Now we have the spectacle of the Conservative Prime Minister (Mr. Clark) and Minister of Finance (Mr. Crosbie) arguing, as the Liberals did when they were in office, that there is nothing which can be done about the increased cost of living.

I found it interesting that the lead speaker for the Liberal party in this debate was good enough to be the lead speaker for that party today, but was not good enough to continue in the cabinet when the Liberals were in office. It was also interesting to hear the former minister of finance tell the House how successful their policies were and how they were able to protect Canadians against a recession when we have had more than three quarters of a million people unemployed for the last two years, and it will get worse as the American economy moves into recession. It was interesting to hear the former minister of finance tell us how successful the wage and price controls were. What the former prime minister ignored so carefully and so deliberately was the promise of his government when they instituted wage and price controls that inflation, which was running at 10.5 per cent when controls were implemented and which obstensibly was the reason for implementing them, would be brought down to somewhere around 4 per cent in the third year. The former minister of finance forgot to tell us in his speech that when his party left office inflation was almost back to the rate it was when they implemented wage and price controls.

What the Minister of Finance and the other representatives of the Conservative government are refusing to tell the people of Canada is that as the cost of living goes up—and we have almost double digit inflation right now—the policies which they propose to implement in moving this country to world crises—
