Mrs. Blackburn died in a car accident in late December. She was the leader of a local section of the Black Sash group of women opposing apartheid and was an opposition party member on the Cape regional council.

Mrs. Blackburn was jailed several times for unauthorized entry into black ghettos, as she was white.

The struggles of Mrs. Blackburn underscore the importance of human rights, and more particularly the need to end the apartheid regime which denies basic human rights, based as it is on the political exclusion of the black majority, the racist operations of the police system, and the over-exploitation of male and female workers through the migrant work scheme. Molly Blackburn fought to put an end to it.

We shall remember her as a staunch defender of the rights of South African Blacks.
