### REASON FOR SIGNING AGREEMENT WITH FRANCE

Mr. Jim Manly (Cowichan—Malahat—The Islands): Mr. Speaker, my supplementary question is directed to the Deputy Prime Minister. When the Minister of Transport, Newfoundland's voice in Cabinet, was asked about the reasons this agreement was rushed through and signed, he said: "I want to find the answer to that myself; I intend to find the answer".
