Provinces, where the privileges of pastoral oversight and gospel ordinances are but rarely enjoyed, and where pure evangelical literature is not within easy reach; and that we earnestly ask from the Christian community such increased aid and support as shall enable the Society to accomplish more fully the work for which it has been instituted.

After this resolution had been heartily endorsed,

was sung, and a collection in aid of Colportage was taken up.
