London Will Speedily Have an Electric Road.

Rails for Springbank Will Be Ordered at Once,

The Bylaw Regularly Passed and Signed.

The Crowd in the Hall Went Wild,

And Even the Aldermen Pounded on the Table.

While No Attempt Was Made to Stop the Din-A Long-to-be-Remembered Night in Council-Even "a Little Dog Darked to See

Such Fun."

Just twenty years ago yesterday the first horse car was pulled over the London Street Railway track on Dundas street. It was therefore a fitting coincidence that the Electric Street Railway Bylaw should receive its third reading and be finally passed and signed on the anniversary of that day. Tonight the aldermen and a few citizens and visitors will be the guests of the mayor at the Tecumseh House. After five council meetings within the short space of eight days, and especially with the bylaw passed and the coveted railway in sight, one will hardly be found to begrudge the City Fathers an evening's

relaxation. It was just 7:30 when an "Advertiser" reporter walked into the mayor's office, which forms an ante-room of the council chamber. Ald. J. W. Jones was the only punctual member of the council last night, and he sat in the mayor's office with his little fox-terrier. This dog, by the way, has at least by his presence shown a deep interest in the subject of an electric street railway, and he was among the first to show his approval of the final passage of the bylaw by a series of barks which were encouraged by the sedate councilors, rather than discountenanced. But to begin at the commencement.

Ald. Brener came in shortly, and Ald. Armstrong. Ald. Heaman and Callahan followed, and then Mr. Ivey appeared. Then a little boy brought in a bundle of printed matter, and like most boys, he was a trifle shy in the presence of civic dignitaries and turned and almost bolted for the door when the sargeant-atarms relieved him of his load. Like other boys, too, he forgot something, as in a few minutes his head appeared again in the door.

"Six of those bylaws are printed on special paper," said he, and the head was withdrawn again.

In the meantime the sergeant-at-arms had distributed about a dozen copies of the documents around the com, but nothing was thought of the significance of the lad's remarks until later in the evening.

The mayor had arrived by this time, and he told the walting aldermen that the city solicitor could not get to the hall until 8 o'clock. He had the bylaw to look over after it finally left the printer's hand.

Manager Carr came in, and Ald. Parnell and the mayor interested those present in a recital of some of the scenes connected with the sudden death of a well-known citizen the night be-Even after the council meeting of Monday night there was business re street railway to be attended to, and the mayor and Mr. Carr were passing the corner of Dundas and Wellington streets at a late hour, when they heard the screams of the afflicted family, and on making their way upstairs they unexpectedly found themselves in the

presence of death. The time slipped by, and the members of No. 3 committee improved the opportunity by holding a short conference on the side. When the city solicitor came in he asked to have a short private talk with the mayor, and the two withdrew. When they came back the aldermen took their places, and the city clerk began a still hunt for the six special copies of the bylaw hereinbefore mentioned by the small boy. They were printed on parchment paper and were to be reserved for the signatures of the different parties to the transaction. A vigorous search was made, and four were recovered. In the cases of the other two, the aldermen, in memory of the auspicious occasion, had inscribed their names on the title page in flaring strokes with a blue pencil. These will be handed down to posterity as heir-

looms. As the aldermen took their places Messrs. Ivey, Carr, Hellmuth and Armstrong, of the street railway company, occupied chairs in the north doorway, and Superintendent Dehart and Messrs. Douglas and Currie, of the same company, sat in the south entrance. Thus it was impossible for the aldermen to escape! A policeman was in the rear, the company on each side of them, and

the bylaw received its third reading. The difficulty at the last meeting was with reference to appeals from the awards of the city engineer and a question as to whether Clark's bridge should These difficulties were amicably settled by the company agreeing to accept the decision of the engineer as final as to the best modern means to be adopted s become responsible man, to prevent injury or interference with any system of waterworks or fire alarm by the company's wires. Appeal will be allowed to the council as to what shall be "the best modern practice" mentioned in reference to safeguards and kinds of cars. If the company is not satisfied with the engineer's award as to "the best modern means" and as to "sufficiency of the means" in the clause binding the company to properly protect all telephone, telegraph, electric light and other wires, appeal may be had to a board of arbitrators composed

of three expert civil engineers. The city allowed the company to build the addition to Clark's bridge in the same manner as the other bridges, insofar as regards the use of the steel cylinders filled with concrete instead of

extending the abutments. The question of possible danger to nedestrians on York street bridge was also happily settled, the company agreeing, provided the city paid \$300 towards the cost, to build a sidewalk for pedestrians her charge, and has two pairs of pedals. around the outside of the extension,

thus making it unnecessary to cross the rails at all.

This was how matters stood when Ald. Jones began to read the bridge clauses. Not more than one bridge on the south side of the city shall be closed for traffic at one time during the progress of the work on the bridges. There was absolutely no opposition

to the clauses, and they were adopted

fully understand what had been agreed upon. "That, Ald. Jones," answered Mr. Meredith, "has been arranged. The actions will be withdrawn and a document signed by the parties before the agreement is signed by the mayor. There is no necessity for placing it in this bylaw. In addition to that the company will abandon the appeal now in the Supreme Court and will pay \$1,000,

asked Ald. Skinner.

Ald. Jones, to whom the solicitor referred the question, said that they would amount to about \$1,200.
Then Mr. Meredith continued: "And the company will also supply the city

arrangement, and as everybody was satisfied, Ald. J. W. Jones was not loth to move the third reading. "Now, Mr. Mayor," said he, "the bill has been read twice, and it affords me great pleasure after the downright hard work we have had together to move that the bill, having been read a third time, the bylaw be now finally passed."

Ald. Armstrong seconded. The show of hands occurred on the call of question, and the vote had been counted, when the sergeant-at-arms heard a remark:

"Here's a vote here." It was Ald. Pritchard's voice, and he gave a tardy "yea" to the passage of the bylaw he had opposed so vigorously. No hands were shown on the call for

Ald. McCallum, sensitive of the delicacy of his position, though in favor of the bylaw, refrained altogether from voting.

The yeas and nays were not called

ILLEGAL IN ILLINOIS.

The Whisky Trust Preparing to Sell Out and Move. Chicago, Ill., May 21.-The most im-

portant move yet made under the direction of the reorganization committee of the whisky trust was made today. The stockholders passed two resolutions, one for a judicial sale of the property and the other for a sale outside of court. It is understood this action is taken to forestall a decision in the Supreme Court upholding the verdict of the court below, which declared the trust illegal under the laws of Illinois. When the judicial sale is consummat ed, it is probable that the Distilling and Cattle Feeding Company will be reincorporated in another State.
