## REPEAL VETO BILL PLAN OF THE LORDS

To Force Asquith to Make Peers Would Mean Suicide.

London, July 8.—Talk of compromise on the constitutional question is filling the air today. The Unionist newspapers at the fifth hour recognize that the King has no alternative but to create sufficient peers to carry the veto bill if the premier so recommends, and say therefore that the House of Lords will commit political suicide if it compels the Government to take that course.  
Hence, with a view to saving the Lords' face, they point to the fact that Viscount Morley in the recent debate in the House of Lords showed a disposition to look favorably on an amendment Lord Newton proposes to move on the report stage of the measure, which provides that no bill for the further limitation of the legislative powers of the House of Lords shall be introduced until after another general election.  
The Unionists are now inclined to regard an undertaking on the part of the Government not to go any further in the direction of a single chamber Government as an acceptable compromise, and if Premier Asquith should decide to accept Lord Newton's amendment it is understood the House of Lords will adopt the veto bill after the House of Commons has thrown out the Lords' amendments.  
It is reported that the Unionist leader has decided upon a policy of acceptance of the veto bill under protest, with the intention to repeal it when they return to power, and then to proceed to reform the House of Lords, and, as soon as possible, introduce the referendum into the constitutional system.

**A Straight Denial.**  
Mr. James, in the box, said he was about three feet away from the bar door when the officers came in. He denied that he had opened the door as the officers had said. He was in the room, he said, because he wanted to direct the porter to clean up the room, and a man was there who had taken sick. As soon as he came out, the four men came in from the hall. He denied the story of Inspector Galpin that from time to time he had taken men to the door of the room, and opened it with a key. Mr. James denied that he had any bottle in his pocket, as had been stated. He claimed that he did not know that the man who came in was Sergeant Birrell and Lucas, and Inspector Galpin.

Cross-examined by Crown Attorney McKillop, Mr. James said he had not seen Pritchard around the house during the evening. He denied that his friend, the bartender (Ratson), and Pritchard, had been placed outside to give warning. ## FATAL TERMINATION OF CHURCH DISPUTE

Drug Clerk Near Cornwall Shot by Reeve Dies of Wounds.

Cornwall, Ont., July 7.—William Shaw, the drug clerk who was shot at Bridge End, Gengarry, last Saturday by F. D. McRae, reeve of Lancaster Township, died at the Cornwall General Hospital this afternoon. The charge of shooting with intent, which was laid against McRae, will now be changed to one of murder when he comes up in a court on Friday.

Shaw was shot by McRae while leaving Bridge End with an automobile party, which had endeavored to get possession of Dr. Magee's baby, which the mother, a Roman Catholic, who had left her husband because of religious differences, possessed. Shaw, Dr. Magee's brother and a chauffeur, went to Bridge End on Saturday in search of Mrs. Magee and child. They went to the home of Mrs. Magee's father, D. C. McRae, but were told they were not there. Farquhar McRae, an uncle of Mrs. Magee, lives alone, and he came along, and trouble arose among the party, with the result that rifles were brought to bear on the situation. The auto party started off in their car, but Farquhar Magee shot after them, and the ball penetrated Shaw's chest. He was hurried to the general hospital, and made an ante-mortem statement, fearing he was going to die.

**THAMESFORD CHILDREN HAD NARROW ESCAPE**  
Boy and Girl Almost Under Hoofs of a Runaway Horse.  
On Wednesday evening at Thamesford a horse belonging to Mr. A. Cartmore, becoming frightened at an automobile ran away at a furious speed, and completely overtook in its wild career a baby carriage in which the little child of Mr. A. Hossick was being pushed by her little brother. The car was demolished, but in some remarkable manner the child rolled out of danger and was not trampled by the feet of the animal nor run over. The wheels of the wagon, however, were terrified for the moment, when the frightened animal careered madly down the street, its speed aggravated by the hubbub of the party who were watching the baby sister failed to notice the horse until it was right upon them. The boy was not hurt at all, but the baby received a slight hurt above the eye from being thrown out of the carriage. The children also suffered from the fright received.

**RUNNING SHORT OF ICE**

The prospects are exceedingly good, and in all probability the firm will locate here.

**END OF BORDEN'S TOUR**  
Portage la Prairie Grain Growers Accuse Him of Insincerity.  
Winnipeg, July 7.—Mr. Borden's tour of the prairie provinces, which opened in Winnipeg on June 19, comes to an end tomorrow with meetings at Morden, Roseland and Summerset, in the constituency of MacDonald, represented by W. D. Staples.  
Today was one of the busiest of the tour. Mr. Borden spoke at Gladstone, a strong Liberal district, in the morning, met the grain growers at Portage la Prairie in the afternoon, and also addressed a large public meeting. Tonight he was at St. Pierre, a French settlement, near St. Boniface.  
The Portage la Prairie grain growers accused him of not being sincere in his stand against reciprocity. He declared that he thoroughly respected their sincerity in favoring it, and expected equal respect for the sincerity of his own views thereon.  
They also accused the Conservatives in Parliament with blocking legislation in the farmers' interests, which brought from him the statement that it was obviously unfair of them to take that stand and let reciprocity blind their eyes to the policy of the Conservatives in respect to chilled meat.
