Guarded Every Minute of the Day and Night, Prisoner Was Talkative on All Subjects But the Crime With Which He Stands Charged.

AN UNEVENTFUL TRIP FROM THE COAST

Swiftly the drama in which Sidney Murrell, desperado, is the central figure is moving.

Last night Murrell reached the end of a whirlwind trip to the Middlesex county jail from San Francisco, the last few miles from St. Thomas to London being completed by automobile.

Today Sidney Murrell's mother will make application to see her boy for the first time in two years. Governor Byron Dawson declares he will turn a deaf ear to her pleas. Sheriff Donald A. Graham is undecided on this point.

Murrell has already laid plans for his defence at his trial for murder or October 2. He has re-engaged J. M. Donahue, barrister, who handled his case before the escape. The prisoner slept well during the night, but lodged strong complaint against prison meals and the loss of his tobacco.

The officers, who arrived in 'Frisco Thursday night, notified the gov-ernor of the jail of their arrival and informed him that they would accept their prisoner the next morning. They were a day late in arriving, due to a wreck at Bitter Creek, which delayed them for 24 hours, but, notwithstanding this, the trip was made in record

He had been kept in ignorance of their arrival and, although he evidently expected to be sent for any day, seemed to give a little start of surprise as the emissiries of the law entered through the barred door, where he had been kept for weeks, awaiting this moment. Strongest Jails.

The San Francisco jail in which Murrell was imprisoned is one of the strongest on the continent, and with wanted man seemed resigned, but glad when the time came to leave it. Guards armed with shotguns and rifles met his view daily as he was taking his exercise in the jail grounds, and his companions were men of the worst type, guilty of the most serious crimes known. Even the officers were glad to leave the grim pile behind them and start for more pictur-

Leaving the jail, with Murrell handcuffed tightly, but not to either of the officers, the party jumped into a waiting motor and were whisked across the city to the ferry which took them to Oakland, where they arded a Southern Pacific train. Surrounded by three or four good-looking girls, and well dressed, he looks the picture of contentment. According to Mrs. Murrell, the only difference is that he looks a little older and more serious. Says He Did Not Save Couple From Going to Burwash Prison Farm.



M. Donahue Engaged This Morning To Look After Prisoner's Interests.

ACCEPTS THE CASE

Will Attempt To Have Client Tried For Robbery Until Others Are Caught.

J. M. Donahue will defend Sidney Murrell, who will be tried at the fall assizes on a charge of murder. Early this morning Murrell his mother, which he received while in the jail, he told her in the letter last night by Provincial Inspectors Stringer and Ward, sent for Mr. Donahue, and asked him if he would de-

fend him when the trial came off.
Although Mr. Donahue will not
make any definite statements regardthe case, he said, he felt sure the attorney-general's department would give some consideration to the advisability of arraigning Murrell on one of the other charges to which he pleaded guilty until such time as the two other men, William Murrell and "Pat" Norton, are also

pprehended.

that Murrell would be tried on a charge of robbery with arms.

Contradicting this opinion is that of Provincial Inspector Stringer, who told The Advertiser, that as Mur-rell had been extradited on a charge of murder, he must be tried on that charge and no other. If he is acquitted of that charge, the authorities must set him free and send him back to the country from which he was extradited. Then they can again begin to search for him, arrest and have him brought back to the other charge, if sufficient evidence is supplied.

Inspector Stringer stated that Murrell had had the best legal opin-ion on this matter when in California and that was the reason for his fighting extradition. Had he been de-ported, he would have been tried on iny charge. Crown Attorney J. C. Elliott made the same statement some time ago when he declared that Murrell could only be tried on the charge which he was extradited.

BANDITS HOLD UP BANK MESSENGERS

Sensational Robbery Takes Place in Center of Toronto's Financial District.

ROBBERS ESCAPE

Two Are Shot in Revolver Due! Between Thugs and Bank Employees.

Special to The Advertiser. Toronto, July 24.—The bandits' haul is estimated at \$80,000, belonging to the Sterling Bank and the Bank of Nova Scotia. The loss is said to be covered by in-

Duck and Harris, the wounded Duck and Harris, the wounded messengers, were in a critical condition at one o'clock this afternoon, but hopes were held out for the recovery of both men.

Notification of the robbery was broadcasted by the Toronto authorities to police throughout Ontario and in American border cities. A red Studebaker car similar to that in which the bandits made their getaway was reported to have been sighted near Mimico, westward bound, shortly after the holdup.

after the holdup. Toronto, July 24.—Bandits and bank messengers engaged in a sensational pistol battle at 9:45 this morning, when six robbers made a daring raid on the messengers of three banks -Sterling, Standard and Commerceas they returned from the clearing house with numerous bags of money.
W. S. Dick, 30 Gough avenue, Sterling Bank messenger, was shot and seriously injured, and James W. Harris, 4 Luttrell avenue, Standard Bank messenger, was shot in the abdomen and the thigh, but brayely returned the robbers fire

The six robbers had a motor car and made their get-away safely with a bag of the Sterling Bank money.
The Sterling Bank men were on foot and the messengers of the other

banks in cars.
As the Sterling Bank into Jordan street, at Melinda, two men from the bandit car approached them and fired. In a moment the men were grappling, hand to hand fashion. The two shots were followed by a fusillade, as the other bers engaged in a revolver battle.

Messenger Returns Fire. Harris proved the hero of the affair. He jumped from the Standard Bank car and opened fire on the bandits. Lying flat in the road, he aimed at the bandits who were carrying a Sterling bag of money across the road to their car.
