Renovations to the existing terminal building will provide a finger with departure rooms along the aircraft apron which could allow the addition of nose loading bridges. A new arrivals concourse including an inspection area will also be developed. In addition modifications to the existing aircraft apron, access roads, and car parking areas are planned. The department's planning for the proposed new terminal complex has not been finalized and, as a result, the cost of the new terminal building has not been established at this time.
