FISHERIES

INQUIRY AS TO PROSPECTIVE PRICES
FOR SEALSKINS

On the orders of the day:

Mr. Andrew Chatwood (Grand Falls-White Bay-Labrador): Mr. Speaker, I have a question for the Minister of Fisheries. I should like to ask him whether, as a result of the discussions the officials of his department had in Europe, he can now give an assurance that the sealers will be able to obtain a fair price for pelts during the coming season.

Hon. H.-J. Robichaud (Minister of Fisheries): Mr. Speaker, it is true that sealskins presently are moving slowly and are being sold at reduced prices. In fact the area where there is the greatest difficulty in selling is in the disposition of white coats. While we expect the production of white coats to be reduced during the coming seal season, I cannot at this time give assurance that the damage done to this industry by exaggerated and distorted publicity will not have some adverse effect on the market in the months ahead.

CANADIAN NATIONAL RAILWAYS
