scribed circumstances. Certainly, I believe this is the way to deal with this matter because if we do not deal with the change from the old grading system to the new grading system, which is more beneficial to the producers, under certain circumstances that would have to be prescribed, we would be failing in our responsibilities and not responding to the requests of the overwhelming majority of producers who are asking us to put provisions in a new Canada Grain Act that will allow them to modernize standards and conditions that are currently desirable in the international grain market.

Before sitting down I wonder if it would be appropriate for me at this point to suggest to the House that we continue sitting past the ordinary hour of adjournment until, say, twelve o'clock, in order that we may complete consideration of this bill and get it on the statute books for the benefit of the farmers concerned. If that is appropriate, Mr. Speaker, I would move that we extend the hour of sitting until this bill is completed, or until twelve o'clock midnight.

Some hon. Members: Agreed.

Some hon. Members: No.

The Acting Speaker (Mr. Laniel): I remind the minister that he needs the unanimous consent of the House to continue the debate beyond ten o'clock. Does the House give the Minister of Agriculture unanimous consent?

Some hon. Members: No.

Mr. Olson: Mr. Speaker, I believe there must be an indication by at least ten members that they do not wish to sit past the usual hour of adjournment.

An hon. Member: Give the farmers a break.

The Acting Speaker (Mr. Laniel): I bring to the attention of the minister the fact that a motion to extend the sitting must be put and if ten or more members do not rise and oppose the motion, it is deemed to be agreed to.

Mr. Olson: Mr. Speaker, I understand that clearly. I therefore move, seconded by the Minister of National Revenue (Mr. Gray), that we sit until we complete this bill or until twelve o'clock midnight, whichever is earlier.

The Acting Speaker (Mr. Laniel): Does the House agree to adopt the motion?

Some hon. Members: Agreed. [Mr. Olson.] Some hon. Members: No.

And more than ten members having risen:

The Acting Speaker (Mr. Laniel): I declare the motion lost.
