PUBLIC SERVANTS—TRANSFERS AT PUBLIC EXPENSE

Question No. 730-Mr. Herbert:

- 1. Is a public servant from a distant city, who enters and wins a competition for a position in the National Capital Region, transferred at public expense?
- 2. Is a public servant in the National Capital Region ineligible to enter a similar competition in a distant city by reason of transfer costs?

Hon. Jean Chrétien (President of Treasury Board): 1. Yes, paragraph 1.04 of the Treasury Board Relocation Directive, December 1973 states: "When an employee is transferred or his place of duty is changed to another location and, in the opinion of the deputy head, payment of part or all of an employee's relocation expenses is warranted, the deputy head may authorize a relocation under the terms of this directive." Paragraph 1.05 states in part: "Once a relocation has been authorized: (a) the employee shall be reimbursed his reasonable and justifiable relocation expenses.—" Paragraph 1.07 states: "Where a relocation results from a transfer between departments, the cost shall normally be borne by the receiving department. However, costs may be shared by the receiving and sending departments where it is to their mutual advantage and prior arrangements have been made."

2. No, a public servant anywhere may enter any competition.

Question No. 768-Mr. Stevens:

- 1. In each year since 1950, what was the number of new companies or corporations incorporated, first under federal jurisdiction and second under provincial jurisdiction?
- 2. How many active incorporated companies or corporations were there as of March 31, 1963, 1973 and 1974 and, in each year, how many were incorporated under federal provincial or foreign jurisdictions?

Hon. André Ouellet (Minister of Consumer and Corporate Affairs): 1. Statistics regarding new provincial corporations have not been regularly maintained by the government of Canada; however, the following figures for new corporations were supplied by provincial authorities for the fiscal year ending March 31, 1973: Newfoundland, 563; Nova Scotia, 1,097; Prince Edward Island, 200; New Brunswick, 949; Quebec, 8,450; Ontario, 12,489; Manitoba, 1,206; Saskatchewan, 985; Alberta, 4,642; British Columbia, 9,422; North West Territories, 93; Statistics regarding new federal corporations have been maintained only for fiscal years ending March 31: 1954, 876; 1955, 879; 1956, 883; 1957, 816; 1958, 788; 1959, 864; 1960, 941; 1961, 878; 1962, 865; 1963, 852; 1964, 917; 1965, 897; 1966, 1,018; 1967,1,085; 1968,1,207; 1969, 1,552; 1970, 1,797; 1971, 1;897; 1972, 1,678; 1973, 2,116; 1974, 2,481.

2. Statistics regarding active provincial or foreign corporations are not maintained by the government of Canada. Statistics regarding active federal corporations are available only as at March 31: 1974, 24,982; 1973, 22,501.
