## **GOVERNMENT ANNUITIES**

SUGGESTED INCREASE IN INTEREST RATE—MOTION UNDER S.O. 43

Mr. Don Blenkarn (Mississauga South): Madam Speaker, I rise under the provisions of Standing Order 43. In February, 1976, Robert Andras, then minister of manpower and immigration, increased Government of Canada annuity interest rates from 4 per cent to 7 per cent. In the communiqué, he stated, "It should be noted, however, that both the increase in the rate of interest and the percentage increase in the annuity will be subject to periodic review depending on future fluctuations in interest rates". The 7 per cent interest rate is now unfair, inappropriate and dishonest. I therefore move, seconded by the hon. member for Prince Edward-Hastings (Mr. Ellis):

That the government do forthwith increase the interest rate on which calculations are based for the payment of the Government of Canada annuities to the same rate of interest presently paid on Canada Savings Bonds, and that the rate of interest on annuities fluctuate with the rate of interest paid to those who lend money to Canada on Canada Savings Bonds.

That the federal government stop dragging its feet in its negotiations with the provinces and allow the grants to be administered by provincial utilities like Hydro-Quebec in order to protect the consumers from rip-offs, and, finally, that the federal government make the \$800 grant exempt from taxation.
