Mr. Broadbent: Mr. Speaker, I thank the minister and I look forward to an early response to the question. As the minister knows, it is the responsibility of the federal government to ensure that the first principle of medicare is implemented nationally, namely, the question of universal accessibility. Is he aware, quite apart from the Marystown example, that in the province of Newfoundland as a whole, health care delivery now is being jeopardized by a complete freeze on the construction of hospitals and the existence of deterrent fees charged to hospital patients? If he is aware of this activity by the present government in the province of Newfoundland, what does the minister plan to do now to ensure that the principle of universal accessibility is as available to the people

Mr. Crombie: Mr. Speaker, with respect to the hospital construction, I am aware of the problem the hon. member raises. I have had some discussions with respect to the principle of universality in Newfoundland. I should like to assure the hon. member that the government of Newfoundland respects that principle as well. As the hon. member is probably aware, in fact they have joined with me in supporting the Hall commission report which will be making recommendations with respect to user charges in April.

CANADA WORKS PROGRAM—REQUEST FOR ADDITIONAL FUNDS

Mr. C.-A. Gauthier (Roberval): Mr. Speaker, my question is for the Minister of Employment and Immigration and concerns another subject. To follow up on my motion, I would like to ask the minister to advise the House whether additional funds will be allocated to Canada Works projects in the next budget.

Hon. Ron Atkey (Minister of Employment and Immigration): Mr. Speaker, the moneys for Canada Works for 1979-1980 have already been allocated. The deadline for applications was September 28—long passed. So the short answer to the hon. member's question is, no, there will not be additional moneys.
