Mr. Hawkes: Mr. Speaker, I ask that all questions be allowed to stand.

Mr. Boudria: Mr. Speaker, I have discussed privately on at least two occasions with the Minister of State (Mr. Lewis) the fact that the rules of the House have not been complied with since Question No. 208, standing in my name, dated October 15, 1987 has not been responded to. You will know, with your vast knowledge of the rules, Mr. Speaker, that that response was necessary on or before November 30.

I know that the Minister of State himself has probably tried very hard to get the answer, but it appears that he is not the culprit. It is, rather, the Minister of whom I am asking the question.

When will the answer be forthcoming and when will the rules of this House calling for an answer in 45 days be respected in relation to Question No. 208?

Mr. Lewis: Mr. Speaker, my colleague is correct in his statement of the facts. I have made inquiries with respect to the answer. I was assured that we would have it for delivery today. We do not.

I can assure the Hon. Member that inquiries will be made more forcefully, and we will get the answer as soon as we can.

Mr. Gauthier: Mr. Speaker, I want to draw your attention to the last comment made by the Minister of State (Mr. Lewis). Without belabouring the point, some months ago the Speaker took under deliberation some comments of mine regarding the present Standing Orders and the request made by Members for an answer to an Order Paper Question within 45 days. In my view there is no remedy available to us or the Speaker with respect to getting the Government to respond. I think it would be appropriate for the Government to say: "I am sorry, we will do our best". That is the spirit in which the Minister of State is responding today.
