Pursuant to the Order of the Day, the following Petitions were severally read:—

Bennett* and others, of the Township of *Algoma*,—of *William Brown* and others, of the Township of *Stafford*,—of *Michael Mulligan*, of the Township of *Bromly*,—of *John Howie* and others, of the Township of *Ross*,—of *John Rankin* and others, of the said Township of *Ross*, in the County of *Renfrew*, severally praying the House to take such measures as to cause the obstructions to the navigation of the *Ottawa* River to be removed, and an uninterrupted line to the full capacity of the leading channel, and the supply of water from the summit level to be opened throughout.

Of *F. Hudon* and others, merchants and traders, of the City of *Montreal*, praying for the repeal of the “*Insolvent Act, 1864*,” and the amendments thereto.

A Message was brought from the House of Commons, by Mr. *MacKenzie* and others, in the following words:—

HOUSE OF COMMONS,  
Wednesday, 21st April, 1869.

Resolved, That a Message be sent to the Senate, requesting that their Honors will unite with this House in the formation of a Joint Committee of both Houses on the subject of the Legislative Printing, and informing their Honors that the Members of the Standing Committee on Printing, namely:—Messrs. *Beaty*, *Bellerose*, *Bowell*, *Brousseau*, *Chamberlin*, *Ferguson*, *McDonald (Lunenburg)*, *Mackenzie*, *Sénécal*, *Simard*, *Stephenson*, and *Young*, will act as Members of the said Joint Committee on Printing.

Ordered, That Mr. *Mackenzie* do carry the said Message to the Senate.

The Messengers were again called in and informed that the Senate will send an answer by a Messenger of their own.

Resolved, That the Standing Committee appointed for the present Session on the subject of Printing, (viz) the Honorable Messrs. *Simpson*, *Burnham*, *Reesor*, *Olivier*, *Sanborn*, *Dumouchel*, *Skead*, *Anderson*, *Lock*, *Steeves*, *Odell*, and *Bureau* be instructed to act on behalf of this House with the Committee of the House of Commons as a Joint Committee of both Houses on the subject of Printing, as desired in their Message of this day.

Ordered, That the foregoing Resolutions be communicated to the House of Commons by one of the Masters in Chancery.
