PITMAN'S BODY CREMATED. London, aJn. 29.-The body of Sir Leac Pitman, the inventor of the Pitman system, who died last week, was cremated at Woking yesterday.

ALLEGED FORGER ARRESTED. Scarborough, England, Jan. 29.-L.R. Jones, an American, proprietor of the Eskdale stud farm, near this place, has been arrested on an extradition warrant, chrging him with forgery, said to have been committed in New York during the year 1894. The amount involved is reported to be \$110,000.

IVORY'S COMPENSATION.
