⁵ To keep this article within manageable bounds, I had to confine its examination of the similarities between then and now to the three topics mentioned in the text. The choice was not an easy one. Many interesting topics must be saved for another day, the chief among them being the 1865 version of Quebec as a distinct society and the rights of the anglophone minority in Quebec. Readers interested in these topics will find helpful materials in the debates. Although I did not find the expression "distinct society" in ipsissimis verbis in the debates, the idea is certainly there. Usually it is expressed in terms of "peoples" and "races." As might be expected, there is considerable confusion and inconsistency in how these terms are used, just as is the case with today's "distinct society." There can be no doubt, however, that the fathers of Confederation saw Quebec as raising questions far more profound than those raised by the defining characteristics of the other provinces. Clearly, they did not see Quebec as simply a province <u>comme les</u> <u>autres</u>.
