Of O. A. Howland, Mayor of the City of Toronto, President of "The Union of Canadian Municipalities," and others; praying that the Bill now before Parliament, intituled : "An Act respecting Telegraph and Telephone Companies," be not passed by the Senate.

Of the Union of Canadian Municipalities ; praying for the passing of an Act giving them full control of their streets, and that no legislation should be passed infringing on such control.

Of the International Railway Company; the Niagara Falls Park and River Railway; the Queenston Heights Bridge Company; the Queenston Suspension Bridge Company, and the Clifton Suspension Bridge Company; praying that the name "International Railway Company" be substituted for the name "Buffalo Railway Company" when it occurs in the Act 63 and 64 Victoria, Chapter 54, and for other purposes.

Of the Timagami Railway Company; praying for the passing of an Act extending the time for the commencement and completion of their railway.

Of the St. Clair and Erie Ship Canal Company; praying for the passing of an Act extending the time for the commencement and completion of their works.

Of John Irving and others, of the City of Victoria, in the Province of British Columbia; praying for the passing of an Act incorporating them a company with power to construct a railway from Kitimat Inlet, in the Province of British Columbia, thence to Hazelton, thence to a point near Teslin Lake or Atlin Lake, thence to Edmonton, in the North-west Territories.

Of George Earl Church and others, Provisional Directors of "The Trans-Canada Railway"; praying for the passing of an Act extending the time for the construction and completion of their railway, granting them running powers over a certain portion. of the Quebec and Lake St. John Railway Company, and for other purposes.

Of G. M. Depew, of the Town of Canandaigua, in the State of New York, one of the United States of America; praying for the passing of an Act authorizing the Commissioner of Patents to receive the fees and issue letters patent for his invention, which lapsed through unforeseen circumstances.

Of James Clarke and others, of the City of New York, in the State of New York, one of the United States of America, and others, of Canada; praying to be incorporated as the North Shore Power, Railway and Navigation Company.

Of the Right Reverend Tikhon, of the City of San Francisco, in the State of California, one of the United States of America, Bishop of the Orthodox Russo-Greek Catholic Church for North America and the Aleutian Islands; praying for the passing of an Act incorporating him and his successors in office, and constituting them a corporate sole, under the name of "The Bishop of the Orthodox Russo-Greek Catholic Church."

Of the Canada and Michigan Tunnel Company; praying for the passing of an Act extending the time for the commencement and completion of their works, and for other purposes.

Of the Canada Southern Railway Company, and the Provisional Directors of the River St. Clair Railway, Bridge and Tunnel Company; praying for an extension of time for the payment upon the stock, under the terms of their Act of incorporation, and also for the commencement and completion of the works of "The River St. Clair Railway, Bridge and Tunnel Company."

Of the Canada Southern Railway Company; praying for the passing of an Act extending the time for the commencement and completion of the railway and branches.

Of the Corporation of the City of Toronto, in the Province of Ontario; praying that the Bill (No. 2) now before Parliament, intituled: "An Act respecting Telephone Companies," and also the Bill (No. 28), intituled: "An Act respecting Telegraph and Telephone Companies," may not be passed by the Senate.

And of the Sydney Real Estate Company (Limited); praying for the passing of an Act to incorporate the "Sydney Land and Loan Company (Limited)."
