effected on July 1, in Rome, but I submit that there ought to be some way, either by proclamation in the Canada Gazette or otherwise, whereby one could ascertain authoritatively what these countries are without having to write to the International Union office at Berne for the information. There are other questions which have been answered in a most unsatisfactory and incomplete way. For the moment however I should be satisfied if some direction could be given as to where one could secure the list so that it would be possible to give advice on the mat-

Right Hon. R. B. BENNETT (Prime Minister): The hon. member has asked a question which, it seems to me, is not unreasonable. Canada has acceded to the Rome convention, and Canada had previously acceded to the Berne convention. I understand the hon. member's question is as to what countries have acceded to both. He has received fair information with respect to Rome, but he finds it difficult to obtain information concerning Berne. Is that correct?

Mr. CHEVRIER: Information in connection with the countries now forming the union.

Mr. BENNETT: Yes.

Mr. CHEVRIER: I believe there are about forty countries.

Mr. BENNETT: It seems to me that the suggestion is not unreasonable. I shall ask the under secretary to get into communication with the proper authority, and a notice can be inserted in the Gazette stating the facts.

While I am on my feet I may say to my hon, friend it has been decided that for the month of September the hours for the Civil Service shall not be different from what they have been under previous regulations. I promised my hon. friend I would give that information in regard to the civil servants.

Mr. CHEVRIER: I am afraid I did not get the effect of the Prime Minister's words. Does he mean that the closing hours, the four o'clock hours, will extend into September?

Mr. BENNETT: No, they will not.
