them as citizens of Canada. Knowing the Indians as I do I am convinced they have the character and attributes which will permit them to become assimilated in our society. They will become citizens of whom we shall be proud, and I hope they can be proud of what we do to help them.

Mr. Montgomery: I have one question on this item. I notice the amount is \$4,500, which is divided into \$2,000 for additional travelling expenses and \$2,500 for additional telephone and telegraph costs. I also note that in the estimates for last year this item was increased by a substantial amount which means that \$4,000 more is required this year for telephone and telegraph items than was the case last year, and an additional \$2,500 is required for travelling expenses. I also note there has been a small increase in the number of people on the departmental administrative staff. I would like to know if this small increase is because of the extra travelling expenses and the cost of telegrams and telephones. Perhaps the minister could offer us an explanation.

Mr. Pickersgill: As a matter of fact, as far as travelling expenses are concerned there is an unanticipated increase in the amount of travelling done by the people in the administrative branch because there has been the gradual establishment of an inspection service.

As for the telegraph and telephone service, the former minister was a minister for this province where the parliament buildings are, and I am minister for a province which is fairly remote. The cost of telephone and telegraph service is therefore considerably higher. In my capacity as the minister for Newfoundland I think I am somewhat more extravagant in the use of the telephone and telegraph services than was the previous minister, and I think a certain amount of the blame for the increase in this service falls on me because I represent a geographically remote province.
