wheat. Its Canadian cash value is approximately \$3 million. It is to be expected that this flour will be sold by the government of Ceylon, and the proceeds of the sale will be used by that government to finance rehabilitation and reconstruction.

Mr. H. R. Argue (Assiniboia): May I ask a supplementary question, Mr. Speaker. Members in all parts of the house will welcome this important announcement. Can the minister say whether, in the opinion of the Canadian government, this will meet the situation so far as Canada is concerned, or is this perhaps a first instalment and may further assistance along the same line be forthcoming later on?

Mr. Smith (Hastings-Frontenac): Mr. Speaker, from the information we have at the present time this is as much as we contemplate doing.

Mr. A. M. Nicholson (Mackenzie): Mr. Speaker, may I ask a supplementary question. Has the Secretary of State for External Affairs been able to consider my suggestion that the former high commissioner to Ceylon, who is so familiar with the work of the Colombo plan, be given the opportunity to make available to the Canadian people some of his information before he takes on his new post?

Mr. Smith (Hastings-Frontenac): Mr. Speaker, in reply to the question by the hon. member I wrote him today and said we would do everything possible to further that end. There is some detail which I set forth in my letter and which he will appreciate, but I hope we shall be able to do something.

ST. LAWRENCE RIVER—PILOTAGE IN INTERNATIONAL SECTION

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, may I direct a question to the Secretary of State for External Affairs. Is the minister aware of the press report in this morning's Globe and Mail to the effect that Nobel prize winner Dr. Linus Pauling has submitted to the United Nations a petition signed by 9,235 scientists, including 36 Nobel prize winners, calling for an international agreement to stop nuclear bomb tests now? Will the government give consideration to supporting this constructive and important proposal?
