### PRIVILEGE

MR. HOWARD (OKANAGAN BOUNDARY)—FAILURE OF DI-VISION BELLS TO RING IN WEST BLOCK

Mr. Bruce Howard (Okanagan Boundary): Mr. Speaker, I rise on a question of privilege. Last night a number of votes were conducted in the House after ten o'clock. When I left my office at 10.15, having finished my work, I discovered that the votes were in progress. The reason I did not know prior to that was that the division bells in the area of the west block where my office is were not working. ## COMMUNICATIONS

TABLING OF CORRESPONDENCE BETWEEN CHAIRMAN OF UNITED STATES FEDERAL COMMUNICATIONS COMMIS-SION AND DEPUTY MINISTER

Hon. Gérard Pelletier (Secretary of State): Mr. Speaker, in accordance with Standing Order 41 (2), I want to table, in both official languages, two letters, one dated May 21, 1971, and written by Mr. Dean Burch, Chairman of the Federal Communications Commission of the United States, to the Deputy Minister of Communications of Canada, Mr. Allan E. Gotlieb, and the other, the latter's answer dated June 7, 1971. The letters deal with the orbital position of the satellites that will constitute the space element of the national telecommunications network of Telesat Canada. Part of this correspondence, that is the letter from the Chairman of the FFC, has already been published in the United States. I, therefore, deem it necessary to make public Canada's answer.
