Hon. Robert L. Stanfield (Halifax): Mr. Speaker, my question is to the Minister of Energy, Mines and Resources, to make sure that I understand what he said earlier.

Is the minister saying, in connection with the Petro-Can purchase and the financial transactions involved, that there is absolutely no financial responsibility on the part of the federal government? Is he saying, not only that the federal government did not engage in any express guarantee, but that by virtue of Petro-Can being an agent of the government, and the implications of that under the Financial Administration Act, there is no financial responsibility on the government of Canada in connection with this transaction by way of guarantee or otherwise?

What provisions were taken with respect to Loto Canada's draw for \$1 million in gold in order to ensure the integrity of the draw and (a) how was the winning number drawn (b) what was the date the number was drawn (c) were all the tickets to the draw distributed prior to the number being chosen?

Hon. Iona Campagnolo (Minister of State (Fitness and Amateur Sport)): Loto Canada's \$1 million gold draw was conducted by Roblet Inc., consulting engineers, with 2 amateur athletes to roll the dice. It followed standard Loto Canada procedures and its integrity was certified by:

a member of Samson Belair, external auditors;

a member of Blaney, Pasternak, Swela, public attorneys and Loto Canada's operational auditor.

(a) The winning number is drawn in the same manner as the intermediate and main draws: i.e. computer random selection.

(b) The Draw for the \$1 million in gold was drawn on October 6, 1978 at 6.30 p.m.

(c) Yes.
