Mr. Crosbie: It turned out it has a six-month termination clause. That is how accurate the Hon. Member's Party has been in this free trade debate.

MINISTER'S HUMOUR—REQUEST FOR APOLOGY

Mr. Brian Tobin (Humber—Port au Port—St. Barbe): Mr. Speaker, banner headlines in *The Sunday Express* in St. John's suggest that some people were insulted.

The Minister's comments that he "doesn't give a damn" what the member for the National Action Committee on the Status of Women in St. John's thinks, or Sister Lorraine Michael of the Catholic Social Action Committee, bespeak of more than just responding to the Hon. Member for Hamilton East.

What is in question here is not the Minister's use of humour, which is well known in this House. What is in question is the Minister's brand of humour.
