Mr. Speaker resumed the Chair; and Mr. *Morris* reported, That the Committee had come to several Resolutions.

Ordered, That the Report be received at the first sitting of the House, on Tuesday next.

Resolved, That this House will, at its first sitting on Tuesday next, again resolve itself into the said Committee.
