Many of our readers will remember the famous Durrant murder case which attracted ao much attention in the United States a few years ago, and which ended, after long fighting in the courts, in the final conviction and execution of the accused. Although Durrant protested his innocence to the last, scarcely any one but his own counsel be-lieved in his innocence. The case is brought most painfully to public recollection by the recent death bed confession of one of the chief witnesses against the unfortunate victim of the law.
