

**Speaker's Rulings—(Continued)**

2. Amendment by Mr. Drew to motion for Mr. Speaker to leave the Chair for the House to go into committee of the whole on a resolution: Mr. Speaker ruled that the proposed amendment could not be received since the original motion was a procedural motion which is made in compliance with an order of the House and one which must be decided without debate or amendment, 218.
3. Amendment by Mr. Diefenbaker which proposed to amend section of a bill moved to a motion for second reading of said bill: Mr. Acting Deputy Speaker ruled amendment out of order on the ground that it anticipated the committee stage of bill, 257.
4. Point of order by Mr. Knowles that a proposed motion to give government business precedence on Wednesday, appearing under the heading "Government Notices of Motions", should not be considered during "Routine Proceedings": Mr. Speaker ruled that motions relating to business of the House are allowed during "Routine Proceedings", 260.
5. Amendment by Mrs. Fairclough to motion for third reading of a bill: Mr. Speaker ruled amendment out of order on the ground that an amendment to a motion for the third reading of a bill cannot deal with any matter that is not contained in the said bill, 284.
6. Amendment by Mr. Stewart (Winnipeg North) to refer a bill back to committee of the whole for the insertion of certain provisions: Mr. Speaker ruled the proposed amendment out of order, 407.
7. Amendment by Mr. Drew to motion for House in Committee of Supply, —That powers granted to Governor in Council under the Emergency Powers Act are repugnant to responsible parliamentary government: Mr. Speaker stated that, though there was doubt in his mind in regard to the propriety of the amendment which reflected upon a statute and which in effect was tantamount to moving for its repeal, he would allow the amendment to stand but he was of the opinion that the amendment should have been directed to the government and not to the statute, 453.
8. Statement by Mr. Speaker regarding the scope and relevancy of debate on a motion to appoint a special committee to consider certain legislation relating to veterans affairs, 597.
9. Amendment by Mr. Brooks to motion to appoint a special committee to consider veterans affairs legislation: Mr. Speaker ruled the amendment out of order on the ground that it proposed to give the committee wider powers than those set out in the notice of motion, 599.
10. Amendment by Mr. Hansell to a motion to appoint a special committee to consider veterans affairs legislation ruled out of order by Mr. Deputy Speaker on the ground that the amendment was a nullity or it would give the committee wider powers than those set out in the notice of motion. 601.
11. Amendment by Mr. Drew to motion for House in Committee of Supply ruled out of order on the ground that the matter contained in the amendment had been debated and decided upon during the session, and also on the ground that an amendment to a motion to go into supply should not relate to a proposed ways and means resolution on the Order Paper, 616.
12. Amendment by Mr. Murphy (Lambton West) to refer subject-matter of a bill to a special committee to consider the said subject-matter: Mr. Speaker ruled the amendment out of order on the ground that forty-eight hours' notice must be given of a motion to appoint a special committee, 649.
