**Mr. Starr:** Is it possible to have the names of those objecting recorded, Mr. Speaker? I ask that they be recorded.

Mr. Deputy Speaker: Order, please. Standing order 6(2) does not require that the names of those objecting be recorded.

**Mr. Knowles:** Mr. Speaker, may I ask the house leader whether he will agree to avail himself of the offer we made earlier this evening to consider and pass the estimates of the Secretary of State tonight?

**Mr. McIlraith:** Mr. Speaker, in reply to the question put to me I must say that there is a situation developing here in which it is difficult to reconcile the rights of parliament and the consensus of the committee to the rights of individual members. I recognize in the circumstances how important some of these matters are to individual members.

But I must also reconcile that with the fact that parliament has a right to take a decision on public business. We have now had a very lengthy and thorough discussion of estimates in this session, and have in prospect another lengthy and thorough discussion of estimates in this session under a new, and we hope improved, system.

I cannot ignore without comment the remark of the hon. member for Winnipeg North Centre, who pretends that because some offer he made was not accepted parliament has somehow not acted correctly. **Mr. Barnett:** Mr. Speaker, I rise on a question of privilege affecting myself and, in my view, all hon. members of this house.

**Mr. Deputy Speaker:** Order, please. The Chair must be guided by the rules and regulations which have been given to the Chair by the house. The Chair has seen that the provisions of provisional standing order 6(2) have been properly carried out.
