- 1. Has West Man Regional Development Corporation submitted a brief to the Department of Indian Affairs and Northern Development outlining a project for an Indian Handicraft Industry that will employ Indians on seventeen Reserves in Manitoba?
- 2. Has the Indian Affairs and Northern Development Department accepted the project and, if so, on what terms?
 - 3. When will the project be formally launched?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): 1. Yes.

- 2. The Department has arranged with West Man to explore more fully the proposal with Indian people. Meanwhile, the Department has agreed to continue financing for the sales outlet at Brandon and employment of an Indian manager to supervise the outlet.
- 3. The Department, in consultation with Indian people, in the Brandon area, will review the West Man proposal and until such a review is completed the Department is not in a position to state whether the program will be launched or in what form the Affairs and Northern Development): 1 and 2. program will be launched.

REPLACEMENT FOR ARGUS AIRCRAFT Question No. 2,052-Mr. Forrestall:

- 1. Further to written question No. 1,629 in which the Minister of National Defence affirmatively indicated that active consideration is being given to a replacement aircraft for the Argus, presently in use by Maritime Command, what specific aircraft are being looked at and to-date, have any evaluations been made and, if so, with what results?
- 2. When will a firm decision be reached?
- Mr. D. W. Groos (Parliamentary Secretary to the Minister of National Defence): 1. As indicated in Minutes of Proceedings and Evidence No. 36 of the Standing Committee on External Affairs and National Defence, both the ORION and the NIMROD are being looked at as possible replacements for the Argus aircraft. Evaluation has not yet been completed as studies are also being conducted on the development of advance maritime patrol aircraft which would embody in both the vehicle and its systems the latest technological advances.
- 2. No decision will be made until phase II of the defence review has been completed.
