AGREEMENT BETWEEN CANADA AND THE UNITED KINGDOM FOR PENSIONERS

Question No. 118-Mr. McCutcheon:

Does Canada have a reciprocal agreement with the UK such that United Kingdom pensioners now living in Canada receive increases in the rate of pension and, if not, are discussions under way relative to establishing a formula for such arrangements and when may a decision be reached?

Hon. John C. Munro (Minister of National Health and Welfare): In 1959, there was an Exchange of Letters between Canada and the United Kingdom on social security which was principally of value to citizens of the United Kingdom who returned to that country from Canada. In the interval, there have been a number of social security changes in Canada. At the present time, consideration is being given to replacement of the present Exchange of Letters by a more comprehensive reciprocal agreement in which the payment of increases in United Kingdom pensions to beneficiaries residing in Canada will be one of a number of factors which will have to be taken into account.

Discussions between officials of Canada and the United Kingdom commenced in 1970. While an early conclusion is desirable, negotiations of this type are by their very nature complex and protracted, and it is difficult to estimate when a revised agreement will be established.
