CANADIAN AMBASSADOR TO CHILE—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

TRANSFERABILITY FROM ARMED FORCES AND RCMP PLANS TO AIR CANADA—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Mr. Terry O'Connor (Halton): Mr. Speaker, pursuant to Standing Order 43 I rise on a question of urgent and pressing necessity. In view of the fact the President of the Treasury Board has consistently refused to recommend that the Canadian Forces and RCMP pension plans be transferable to Air Canada's pension plan, and in view of the basic inequity thus caused, particularly to airline pilots who have served in the Armed Forces or the RCMP and who have taken positions with Air Canada, I move, seconded by the hon. member for Prince George-Peace River (Mr. Oberle):

That this House requests the President of the Treasury Board to correct this basic inequity by permitting the transfer of credits under the Armed Forces and RCMP pension plans to the Air Canada pension plan.
