In response to the question of the Hon. Leader of the Opposition, this Party needs no lessons in Canadianization. It was in 1977 that the Conservative Opposition stated as a specific objective of its energy policy that it wanted to see 50 per cent of the industry owned by Canadian companies. That is a policy that we stand by. This energy accord fully supports that. As my colleague, the Minister of Energy, Mines and Resources, has said on many occasions, we are committed to achieving that.

The impact of deregulating oil and natural gas prices without other changes in taxation or royalties was simulated. Based on this assessment, we concluded that as many as 100,000 jobs might be created. The Council also simulated various possible tax changes.

It goes on to say:

It is difficult to make precise comparisons, but it is well known that tax cuts usually have a stimulative effect.

In other words, it is saying that there are more than 100,000 jobs that were referred to in the previous work.
