# SYNCRUDE PROJECT—FEDERAL FUNDING INQUIRY

**Mr. Ian Waddell (Vancouver—Kingsway):** Mr. Speaker, my question is directed to the Prime Minister. On January 7 the Premier of Alberta, Mr. Getty, told an Alberta Legislative news conference concerning the proposed federal loan to Syncrude, the oil sands project: "I know I had the support of the Prime Minister and the Deputy Prime Minister". I repeat what he said: "I know I had the support of the Prime Minister and the Deputy Prime Minister for the federal loan". Did the Prime Minister promise Mr. Getty aid for the Syncrude project or not?

**Right Hon. Brian Mulroney** (**Prime Minister**): Mr. Speaker, we discussed, among many other things, problems in the energy industry, and that was one of them. Premier Getty put out his view that this, among other ways, would be a very good way for the federal Government to co-operate—recognizing the limited existence of resources federally—that this would be a good way to co-operate with the Government of Alberta.

Am I to understand, then, from the Prime Minister's answer that he acknowledges it was there? It is a national problem. We all have to work together with Alberta to try to bring about a resolution to a difficult problem.
