WILD ANIMAL AND PLANT PROTECTION ACT

MEASURE TO ENACT

Hon. Frank Oberle (for the Minister of the Environment) moved that Bill C-42, an act respecting the protection of certain species of wild animals and plants, be now read the second time and referred to Legislative Committee C.
